SHORT TERM TENDER NOTICE

(FOR INSTALLATION OF COMMISSIONING OF LIFE SIZE METAL STATUE OF "BHAGWAN BIRSA")

NOTICE No.: 04/2023

Sealed tenders are invited from manufacturers/sculptor, for the commissioning of life size Metal Statue of "Bhagwan Birsa" for installation at Bhagwan Birsa Biological Park, Chakla, Ormanjhi, Ranchi.

Interested manufacturers/dealers can purchase the tender document from the Office of the Director, Bhagavan Birsa Biological Park, Ormanjhi, Ranchi on payment of Rs. 1000/- by way of Cash or Demand Draft/ Banker cheque in favour of Member Secretary, Jharkhand Zoo Authority, Ranchi from any nationalized bank, on all working days upto 11.00 AM of 20.03.2023. Further details or information can be obtained from the said office. Last date for submission of tender is 20.03.2023, till 12.00 PM. Technical Bids will be opened on 20.03.2023 at 12.30 PM in the **Bhagwan Birsa Biological Park, Ormanjhi, Ranchi**. Financial bids will be opened immediately after processing the technical bids at the same venue as indicated above.

1. Scope of Work

Commissioning of life size Metal Statue of "Bhagwan Birsa" as per the following specifications/dimensions with pedestal design.

- Size of Metal Statue 30' Height from Arrow to Leg Metal Mural (3'x5') 10 nos.
- Surround wall for Metal Mural 40'x40'x5' size of pedestal 15'x15'x8'

2. Terms and conditions of the Tender:

- (i) The bids shall be given separately in two sealed envelopes, one containing the **Technical Bid** and the other containing **Financial Bid**. Both the envelopes should be superscribed as such. The envelopes containing technical bid and financial bids should be put in a bigger sealed envelope, superscribed with words "Tender For The Commissioning of life size Metal Statue of "Bhagwan Birsa" for installation at Bhagwan Birsa Biological Park, Chakla, Ormanjhi, Ranchi.
- (ii) Tenderers should have an experience of at least 3 years in making Metal Statues.

- 3. The technical bids shall contain following information along with supportive documents:
 - i. Tenderer's complete identity and address, and proof of Address.
 - ii. A photocopy of GST registration certificate (As applicable) and up-to-date clearance certificate from the concerned department.
 - iii. EMD: A Bank Draft from any Nationalized / Scheduled Bank for an amount of Rs. 50000/- made in favour of the Member Secretary, Jharkhand Zoo Authority, Ranchi.
 - iv. The letter of Undertaking that the tenderer is not black listed, as given in Form-B
 - v. The money receipt/ receipt in original, as a proof of purchase of the tender document.
 - vi. Copy of PAN
 - vii. Copies of Income Tax Returns for the last three financial years.
 - viii. Self declaration that company has hat been black listed by any Government Agency.
 - ix. Design, specifications and photographs of the Statue proposed to be supplied. The photographs should be from at least four different angles in "Portrait lighting" for better view. The information under this clause should also be provided as a power point presentation with high resolution photographs in a pen drive as part of the Technical bid.
 - x. Signed tender document. (Every page should be signed with date & stamp).
- 4. The financial bid shall be given in Form-A and the amount quoted shall be inclusive of all taxes, duties, transportation, installation charges etc until commissioning of the unit.
- 5. The envelops of Financial Bids of only those tenders who would technically qualify would be opened.
- 6. The successful Tenderer will have to enter in to an agreement for the installation of life size Metal Statue of "Bhagwn Birsa" as per the rates decided, and as per the requirement of the park, within the time period given after the conclusion of the tender process, along with a security deposit of 10% of the value of the supply order, in the form of a DD or Bank Guarantee drawn/made in favour of Member Secretary, Jharkhand Zoo Authority, failing which the EMD will be forfeited.
- 7. The EMD of the successful tenderer would be adjusted towards security deposit, which will be refunded to him after successful completion of the job. If the successful bidder fails to complete the supply of the items complying fully with the quality standards, his security deposit would be forfeited. The EMD of the unsuccessful bidders would be refunded to them after the finalization of tender.

- 8. The successful tenderer should agree to supply the items as per the order at the L1 rates obtained in the tender process for such items.
- 9. The supplies are to be made at Bhagavan Birsa Biological Park, Ormanjhi, Ranchi as per the agreement entered or work order given by the Director.
- 10. The supplier should submit the bills of the supplies made to the Range officer incharge and payment will be made thereafter based on the availability of fund and the allotments in the relevant head. Payment would not be made for any defective supply.
- 11. The successful tenderer shall not have any right to subtender or give any part of the tender to other suppliers.
- 12. If any information provided by the tenderer is found to be false at any stage subsequently (i.e after giving tender), his tender or the work order would be cancelled and the EMD or the security deposit, whichever is applicable, would be forfeited.
- 13. Any postal or other delay, resulting in non-receipt of tender in time will not affect the tendering process and such tenders would not be evaluated.
- 14. The tender shall be unconditional. Conditional tender would not be evaluated.
- 15. Any dispute arising out of this tender and supply would be referred to the Chief Conservator of Forests and Director, Bhagwan Birsa Biological Park, Ranchi for decision which will be binding on all parties.
- 16. The competent Court at Ranchi would have Jurisdiction for any legal issue.
- 17. Taxes, required to be deducted at source, would be deducted from the payment bills.
- 18. The tender inviting authority reserves the right to reject any or all tenders without assigning any reason.
- 19. Submission of Tender: Tenders complete in all respects shall be submitted within the time period given in the tender notice, in the office of the Director, Bhagawan Birsa Biological Park, Ormanjhi, Ranchi, and no tenders will be accepted after that.
- 20. Any correction or cutting in the tender including price bid shall be authenticated by full signature of the tenderer.
